I hereby confirm by signing below that I have been familiarised with and will comply with the regulations of FIA and FIM Europe, the valid Operating Rules, the Traffic Rules of Autodrom Most a.s. (hereinafter "ADM"), the guidelines for test drives and the instructions issued by ADM employees.

I hereby declare that my health condition is good enough for me to drive a motor vehicle and I will not drive at the autodrome while under the influence of alcohol or other psychoactive substances.

I am participating at my own risk, I am aware of my civil legal liability for any damage caused to Autodrom Most a.s. or to third parties, and I accept liability for the actions of persons accompanying me. The legal representative of each participant who is a minor shall assume civil legal and criminal liability for such minor. I am also fully aware of my potential criminal liability for actions that contravene legislation. When driving, I shall take actions to ensure that damage to property, health and the environment does not occur, and I will act in a considerate manner towards the other participants.

I also bear in mind that the race track is not a public roadway, and therefore neither insurance of liability for damages caused to third parties (compulsory/lawful insurance) nor contractual insurance of liability for damages (accident insurance) applies to the use of the race track.

I hereby declare that the vehicle that will be driven in this event is in a sufficient technical condition for operation on a race track and that it is safe for me and for the surroundings.

INSTRUCTIONS FOR TEST DRIVES

The test drives are for testing sport and travel vehicles of racing teams and individuals without ensuring of safety and with the participants carrying out the test drives at their own risk. All participants hereby confirm by signing below that they have been familiarised with and are obliged to comply with the regulations of FIA and FIM Europe, the valid Operating Rules, the Traffic Rules and Commercial Terms and Conditions of Autodrom Most a.s. (hereinafter "ADM"), and the instructions issued by ADM employees.

All payments for test drives, rental of service boxes and return of the keys to the service boxes shall be carried out in the presence of the employee organising the testing.

Each participant is required to provide first aid to any injured persons who need it in the event of an accident. No participants may be under the influence of alcohol or other addictive substances or in a condition of reduced attentiveness and concentration. ADM employees are entitled to conduct a breath test to detect alcohol or a test for other psychoactive substances of any participants or those accompanying them, and neither any participants nor anyone accompanying them are permitted to refuse such tests. ADM reserves the right not to allow a participant and/or vehicle onto the race track or to exclude a participant from use of the track without compensation.

Each participant in a vehicle is required to use a safety belt and protective helmet whenever the vehicle is being driven. Each participant riding a motorcycle is required to have an appropriate suit with protectors, riding shoes, gloves and a protective helmet. The equipment must be intended for use when riding a motorcycle.

The racetrack shall be entered through the pit lane, at the end of which there is a traffic light. The participant may not enter the track if at the exit from the pit lane there is a red light or if an ADM employee signals with a red flag reading "STŮJ".

Exiting from the race track is permitted only via the pit lane, which begins in the second to last turn before the target level after track commissioners' station No. 12. When exiting the race track, the participant is required to signal that intention to other participants, and the participant's manoeuvres must not jeopardise the other participants' safety in any way.

Since the race track is not secure, flag signalling is also not carried out at the track commissioners' stations, and the participant is required to monitor the situation on the race track, especially when passing. In the event of an accident involving a different vehicle on the race track or in its direct proximity, the participant shall be required to report the situation immediately to an ADM employee in the starting tower.

Driving on the race track is permitted only in a clockwise direction. Backing up, turning around and stopping on it or in direct proximity to it is PROHIBITED.

NOTICE TO PARTICIPANTS

Each participant is responsible for securing his belongings against theft.

The maximum permitted speed in the parking area is 30 kph.

Movement of unauthorised persons at the start area, at the finish line or on the race track and in the pit lanes is PROHIBITED.

SMOKING IS PROHIBITED in the entire area of the pit lanes, the start and the finish line. In all areas with signs prohibiting smoking and handling of open flames, it is PROHIBITED to use grates and grills for preparing food.

Driving on the race track under the influence of alcohol or other psychoactive substances is STRICTLY PROHIBITED.

The service roadway is intended only for quick movement of paramedic vehicles, security and ADM vehicles. Its use by other types of vehicles is PROHIBITED.

In the event of a breach of any of the provisions hereof, ADM shall be entitled to react in accordance with the valid Operating Rules.

CONSENT TO PERSONAL DATA PROCESSING

In accordance with Act no. 101/2000 Coll., as amended (Act on Protection of Personal Data and on amendment of certain laws, hereinafter the „Act“), I consent to the processing

of personal data by AUTODROM MOST, a.s., with seat at Tvrzova 5, 434 01 Most (hereinafter referred to as the „Controller“) for:

- a. marketing purposes of the Controller, i.e. mainly offer of products and services (own or alien), communication of information about organised events, products, services and other activities, contacting of the customer for the purpose of market surveys and marketing surveys, where the customer is contacted by e-mail or phone, as well as dispatch of business conveyances by electronic means according to Act no. 480/2004 Sb., as amended, regardless of whether the marketing purposes are realized by the Controller, and subjects, which are controlled by the same entity that controls the Controller by course of Act no. 90/2012 Coll., the Commercial Corporations Act (hereinafter referred to as „affiliates“), or other subjects, to which the Controller delegates the realisation of these marketing subjects;
- b. the purposes of analysis of the personal data of customers that makes it possible to directly contact specific customers and certain groups (so-called, direct mailing);
- c. the purposes of holding, organizing and evaluation of various types of competitions, surveys and other events, which are not consumer lotteries, regardless of whether the customer has a possibility to receive a material or financial prize or without such possibility, where such competitions, surveys or other events may be organised by the Controller as well as subjects, which are affiliates of the Controller or other subjects, to which the Controller assigns the holding, organizing or evaluation of various types of competitions.

Personal data means information contained in this form, i.e. in particular the name, surname, date of birth, e-mail address.

The Controller shall process the personal data manually and automatically directly through its employees and further through processing entities delegated by the Controller and through third parties, which shall be delegated by the Controller to process the personal data on the basis of contracts concluded pursuant to Section 6 of Act no. 101/2000 Coll., on protection of personal data, mainly through subjects, which are affiliates of the Controller. This consent shall be granted for a maximum term of 10 years from date of consent.

The customer is by law entitled to access his personal data that is being processed by the Controller (mainly the right to receive information about the purpose of such processing, scope of the processed personal data and its source, nature of the processing and the recipient(s) of the personal data). The Controller shall provide such information to him without undue delay at a reasonable fee that does not exceed the costs essentially incurred in the provision of information. Should the customer ascertain that processing of his personal data infringes the protection

of his private or personal life or in breach of law, he is entitled to request the Controller or other processing party delegated by Controller for an explanation and remedy such state.

By course of Section 7 (2) of Act no. 480/2004 Coll., as amended, I further agree that the Controller or other party delegated by Controller, mainly AUTODROM MOST a.s., can use the details in the electronic contact information for the purpose of distributing commercial conveyances by electronic means, which concern both the products and services of the Controller, as well as other subjects, mainly, the commercial partners of the Controller.
