By the registration for 3 days (28-30/07/2017) the entry fee is **€200**. The organiser will select the applications and advise the riders within 72 hours after the closing date of the entries if their entries have been accepted or rejected (by publishing the entry list on www.autodrom-most.cz).

9. TECHNICAL CONTROL AND VERIFICATION

No rider or machine is permitted onto the track unless he/it has passed the technical inspection scheduled on:

Technical Control Area Thursday 16.30 – 18.30 hrs
Friday 08.00 – 13.00 hrs

The machine must meet the technical rules of RR for all practising and races.



During these inspections, the helmet and clothing must be presented.
A dynamic noise test will be conducted during the training sessions.

10. RIDERS BRIEFING

A compulsory briefing will be held on Friday 28/07/2017 at 10.30 hrs (after the first free practice). All riders must be present and minors must be accompanied by a parent, guardian or team manager.

11. PRACTICE

The last race will be awarded with double championship points.

14. OPENING CEREMONY

The official opening ceremony with all riders will take place on Sunday 30/07/2017 at 10.30 hrs.
Only the rider + one national delegate shall gather in the grid with a national flag in front of each (country) group.

15. PRIZE GIVING CEREMONY

Venue of the prize-giving ceremony: by the Media Centre after each race

The first three riders are invited to attend the prize-giving ceremony.

Additional other riders can be invited the organizer. Riders might also be invited for a Press Conference.

If invited attendance to the prize giving ceremony or press conference is compulsory.

The final prize-giving ceremony for the European Championship will be held on Sunday 30/08/2017 at 15:00 hrs at the podium.

16. PROTEST AND APPEALS

Any person or group of persons (rider, entrant, manufacturer, official, etc.), recognized by the FIM and concerned by a decision taken under the authority of the FIM Europe, may ask for redress for the consequences of that decision.

Protest must be lodged according to the FIM Europe Disciplinary and Arbitration Code and the Supplementary Regulations and be accompanied by a fee of 130,- € or equivalent amount in local currency, returnable if the protest is justified.

In general, protests against eligibility of a rider entered, must be made before the start of the official practice.

Protests against results must be presented to the International Jury within 30 minutes following the publishing of the results.

An appeal can be made to the FIM Europe Disciplinary Commission against a decision of the International Jury.

Protest entailing a fuel control: See FIM Europe RR rules.

17. FUEL

In accordance with FIM specification.

There will be no fuel supplied by the organiser in the paddock.



18. INSURANCE

The organizer has contacted a third party insurance in accordance with Art. 110.1 of the FIM Europe Sporting Code. This insurance includes a guarantee of the minimum amount as stipulated by the FIM Europe Management Council. The Insurance comes in effect 2 days before the first practice and ends 2 days after the meeting.

The organizer disclaims all responsibility for damage to a motorcycle, its accessories and components arising out of an accident, fire or other incidents.

19. RENUNCIATION OF ANY RECOURSE AGAINST SPORTING AUTHORITIES

Apart from the requirements of the FIM EUROPE Sporting Code, riders and passengers by participating, renounce all rights of appeal against the organizer, his representatives or agents by arbitration or before a tribunal or any other manner not foreseen by the FIM EUROPE Sporting Code for any damages for which they could be liable in consequence of all acts or omissions on the part of the organizer, his officials, representatives or agents in the application of these regulations or contributed to or arising out of their actions.

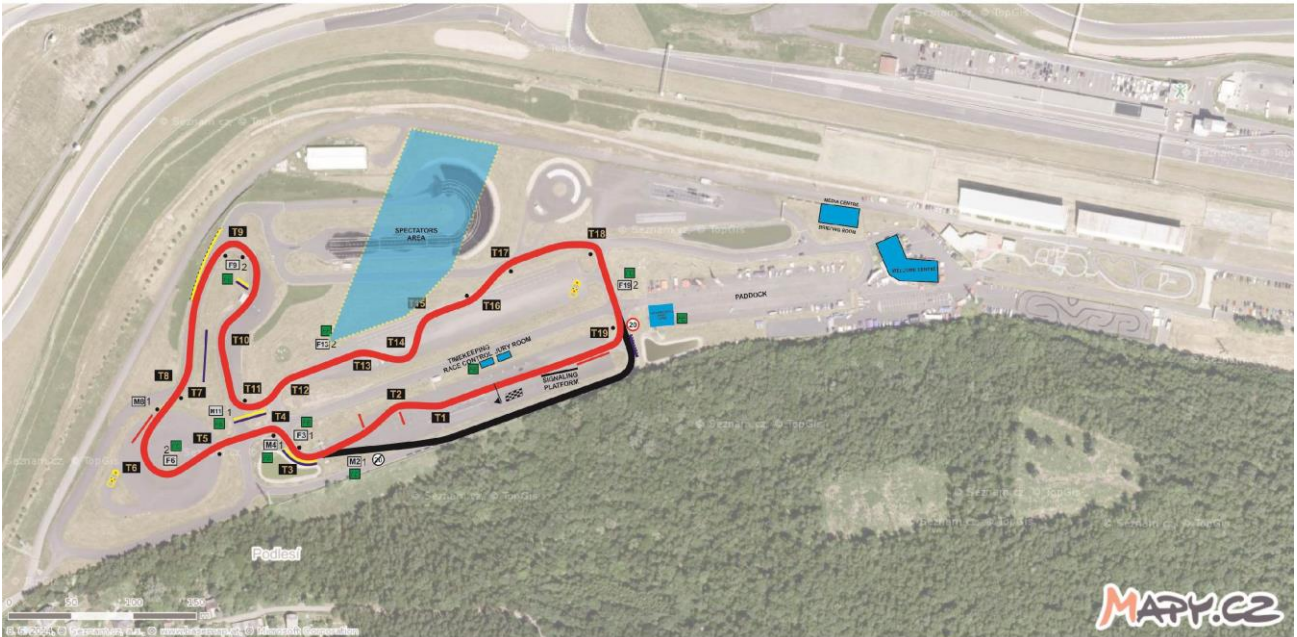

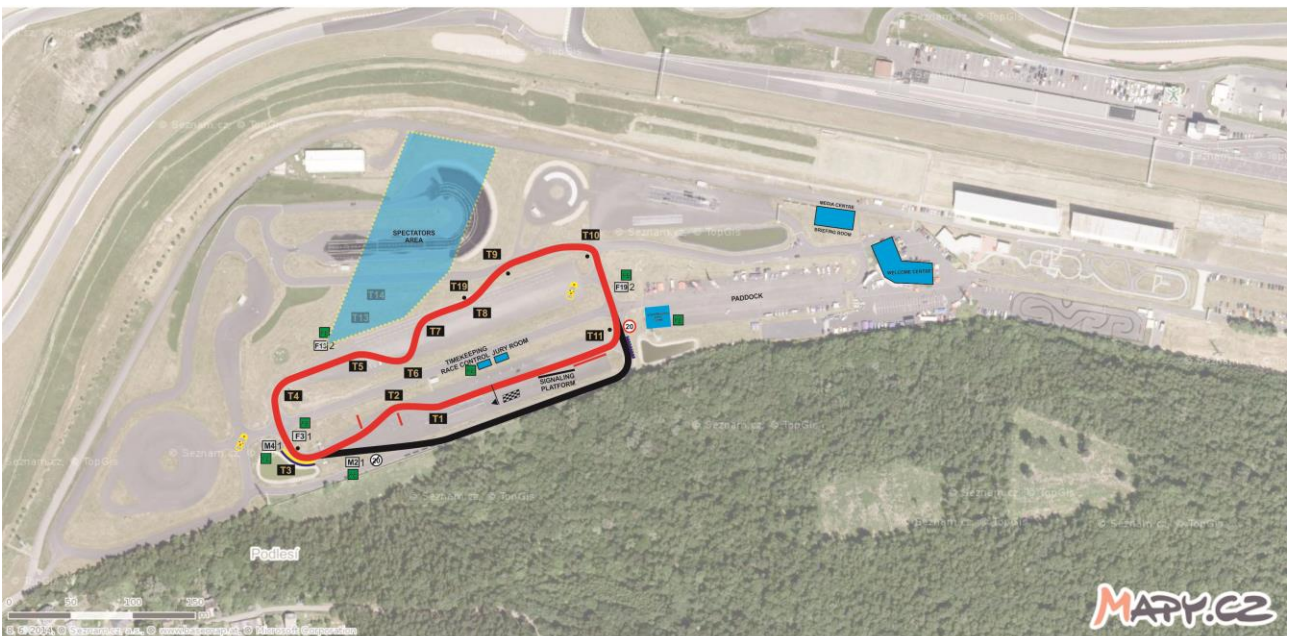
